REQUEST FOR QUALIFICATIONS FOR PROFESSIONAL ENGINEERING SERVICES

Public Water Supply District No. 3 of Johnson County, Missouri, (PWSD No. 3) is requesting qualifications to provide professional engineering services to assist with the following projects:

- Drilling of new high service well located within the Hickory Hills Subdivision
- Design/Build a new above ground pump station
- New chlorine room at Hickory Hills well site
- Sand blast, paint, and repair existing water tower located along SE 251 Rd. Three (3) coat epoxy system must be done according to Missouri Department of Natural Resources standards
- Rehabilitation of existing Well No. 3 located along SE 251 Rd.
- Assist with the identification and application in order to secure financing and grant opportunities
- Provide qualified on-site inspections
- Survey and assist with property purchase
- Tie in SCADA system for new projects with existing system
- Sand blast, paint, and rehab two (2) existing clearwells

PWSD No. 3 is seeking funding from United States Department of Agriculture Rural Development (USDA), Community Development Block Grant (CDBG), Missouri Department of Natural Resources (MoDNR), and Environmental Protection Agency (EPA) to assist with the cost associated with the above projects.

Information provided to PWSD No. 3 must include:

- The specialized experience and technical competence of the firm with respect to water production and distribution.
- The capacity and capability of the firm to begin work by December 31, 2020, to perform the study of the water system and be completed within 6 months of Notice to Proceed.
- The firm's past record of performance with respect to similar projects, including control of costs, quality of work, and ability to meet schedules.
- The firm's proximity to and familiarity with the area in which the project is located and the concerns of PWSD No. 3 that are to be addressed in the report.
- Key personnel qualifications with respect to water tower rehab and painting.
- Provide references from previous clients of related work with the firm within the past five year.
